**7. Page 325, 326 and 327**

**Revise the following course descriptions:**

**HI 211 United States History I**

An introductory survey of the United States from colonial times to reconstruction, focusing on the development of its politics, government, and social institutions.”

**HI 212 United States History II**

An introductory survey of the United States from reconstruction to the present, focusing on the development of its politics, government, and social institutions.”

**HI 265 Minorities in America**

An examination of the impact, contributions and struggles of women and various ethnic minorities in the United States.

**HI 318 Latin American History**

This course is a thematic survey of Latin American History emphasizing community, conquest, colonialism, revolution, and neo-colonialism. Within this framework, students will examine the intersection of diverse peoples, culture, and class.

**HI 350 History of the American Civil Rights Movement**

This course is an in-depth exploration of the American Civil Rights Movement of the 1950s and 1960s inclusive of precursory developments. Key events, personalities, and regions will be covered, as well as the relevancy of the movement on modern society.

**HI 459 Recent American History (W)**

This course will cover American society, politics, and culture from the end of World War II to the present. It includes a special focus on the effects of U.S. foreign policy on domestic life.

**HI 469 Modern Europe (W)**

This course delves into the contributions of European history to the development of the

modern world. It explores post-WW2 Europe linking specific nations, movements, and landmark events in European history to broader historical themes and problems that have shaped the contemporary era.

#### **HI 480 Research Seminar (W)**

Research Seminar is an exploration in research and historiography methods that equip students to do historical research. Strategies include the identification, location, analysis, and utilization of primary and secondary source. Students will exhibit proficiency in the integration of multiple perspectives with proper citations

#### **HI 495 Capstone Senior Seminar**

The Capstone Senior Seminar is the culmination of learning in the core curriculum. The course is designed to demonstrate critical thinking and salient points of learning in the discipline in preparation for graduate/professional schools and careers. Student will complete a comprehensive portfolio with artifacts that exemplify mastery of historical analysis and research.

### **8. Page 364**

#### **Replace the following:**

Description for PL 115 should read “This introductory course will examine all aspects of majoring in Pre-Law and Legal Studies. Students will be introduced to law, the process for becoming a legal professional, how law is practice, and different career and educational opportunities within the profession. Students will be given tools that can be implemented throughout the rest of their educational experience.”

From the Pre-Law course descriptions, remove the prerequisite of PL 275 from PL 280 Legal Assistant Certification.

**Remove** PS 440 International Relations (W). Then created a course description section for International Relations

**Relist** the course as “IR 440 International Relations (W)

A study of critical factors affecting the conduct of international relations. Emphasis is placed on nation-states, global and regional international organizations, multinational corporations, individuals in the international arena, and the forces they bring to bear on the international political system. Prerequisite: EN 112 and PS 120.”
